On behalf of Mosaic Fertilizer, L.L.C. (Mosaic), we are pleased to submit nine (9) rezoning applications for the DeSoto Mine and adjacent lands. Incorporated into this rezoning application package you will find the following:

Phosphate Mining Overlay District in the NW corner of the unincorporated DeSoto County where the Comprehensive Plan Future Land Use Map / Phosphate Mining Overlay District identifies phosphate mining as an approved land use.

OWNERSHIP STATUS

Mosaic owns fee simple 9,482.4 acres and has mineral interest / controlling rights (aka: Hollingsworth, Brewers, DiMare) over 4,575.1 acres that are addressed in this application. Together these lands total 14,057.5 acres and make up this rezoning request. Please refer to the Ownership / Mineral Interest section of this rezoning application for more information. Accordingly, the rezoning application provides copies of the fee simple, permitting agreements and mineral interest deeds for the properties that make up this application. These enclosed documents authorize Mosaic to rezone and apply for the necessary permits to include these lands in the proposed DeSoto mine or future expansions.
