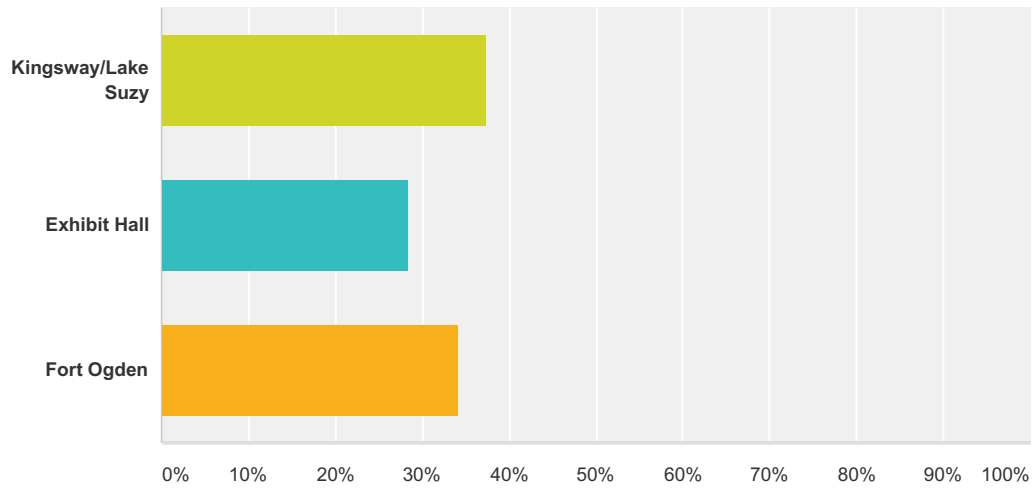


Q1 Please tell us the location of the Community Conversation that generated this survey

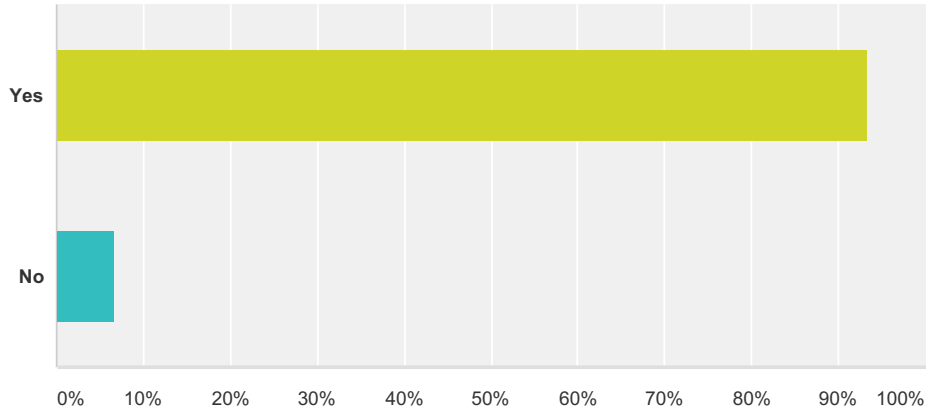

Q2 Do you support the use of performance based economic development incentives such as the Business Incentive Grant Program or Ad Valorem Tax Abatement?

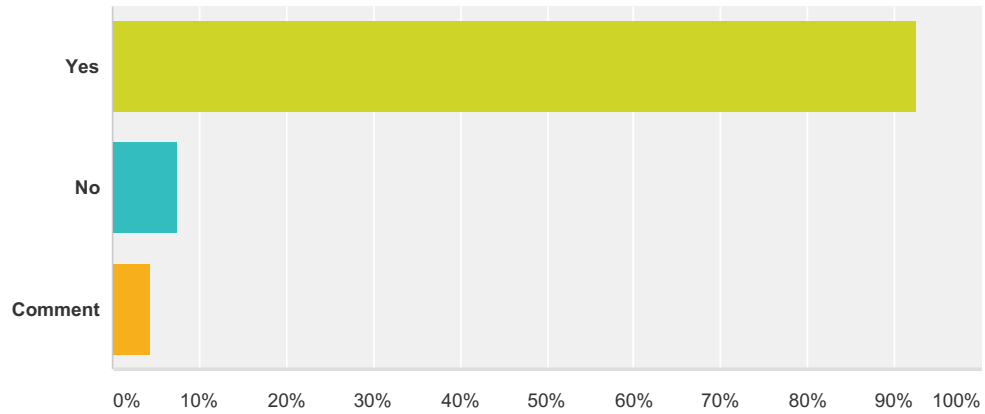

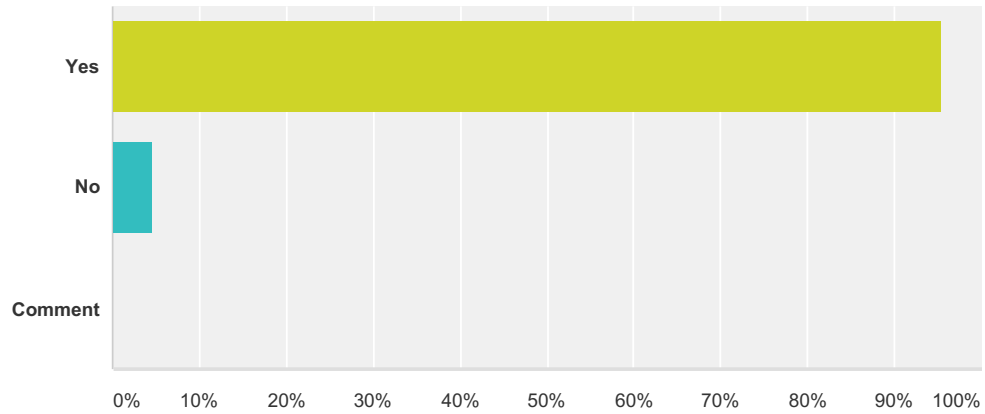

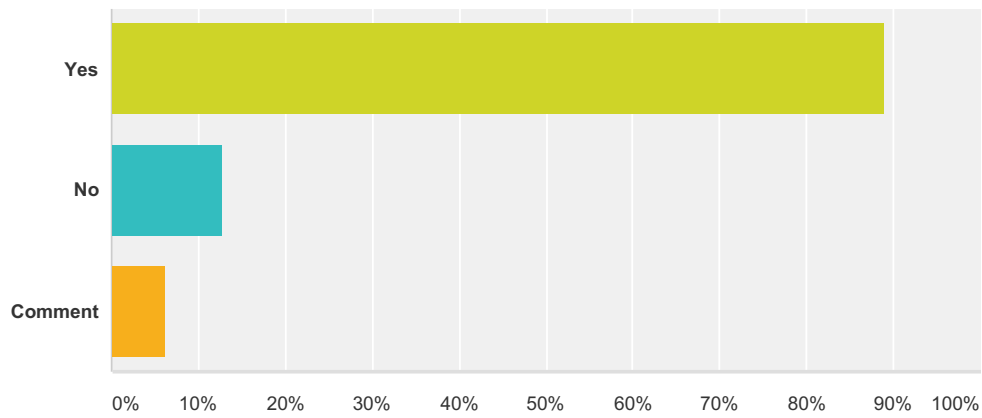

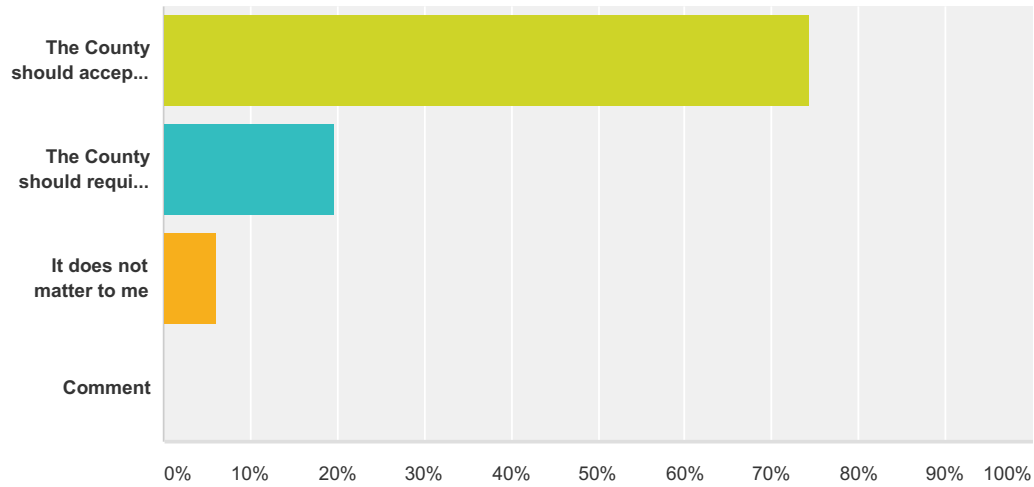

Q8 Do you think the County should accept anonymous code enforcement complaints, or do you think people who call to report violations should be required to provide their names/addresses?

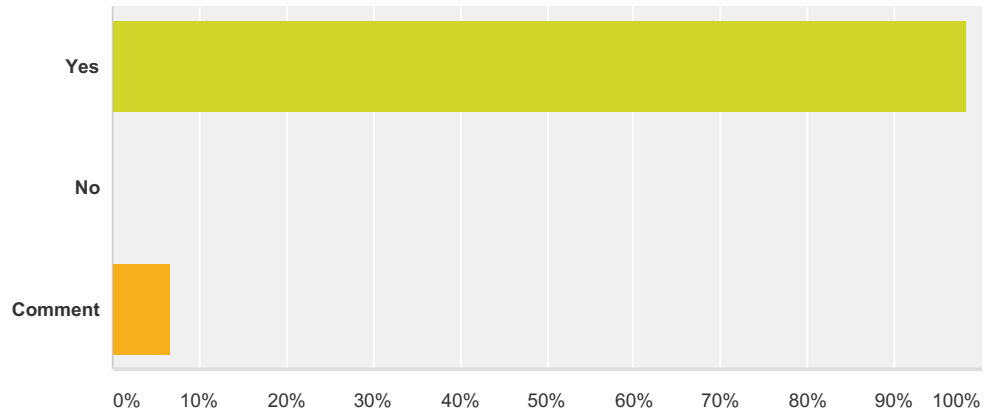

Q9 Based on this evenings presentation, do you feel that the County is acting in a responsive manner to address the areas identified by participants as "High Priority"?

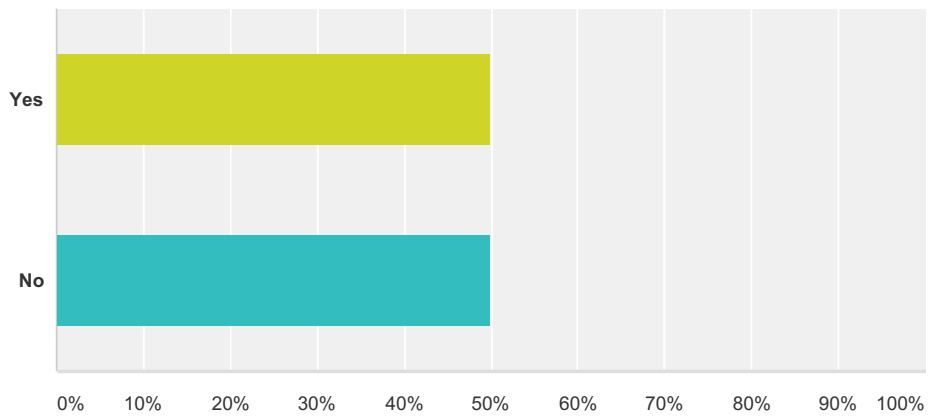

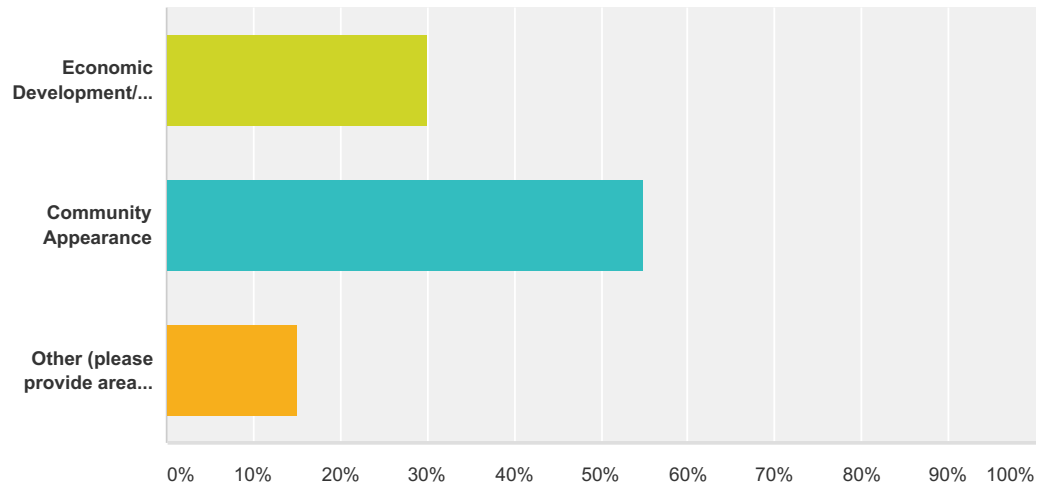

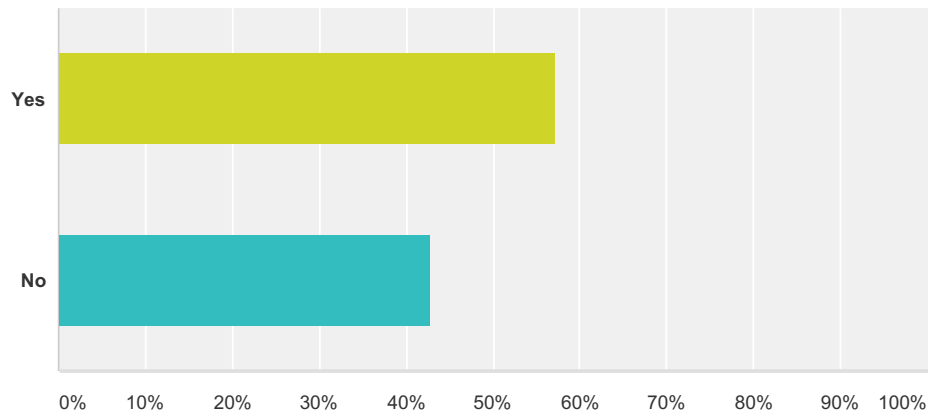

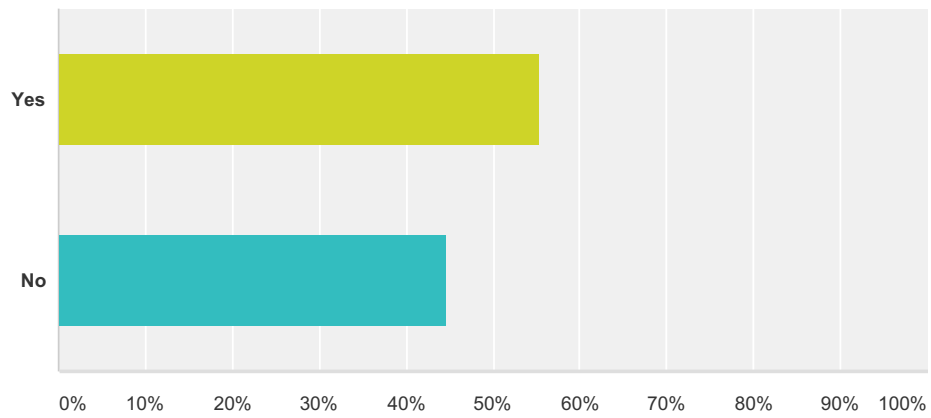

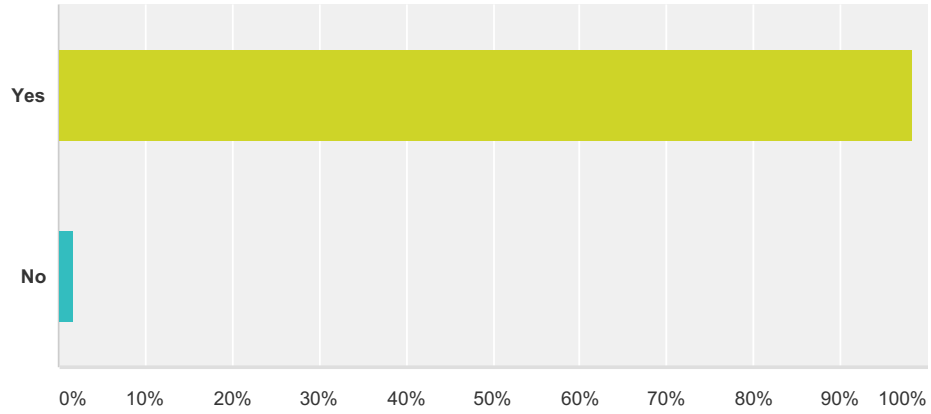
