DESOTO COUNTY, FLORIDA RESOLUTION NO. 2020-86

A RESOLUTION OF DESOTO COUNTY, FLORIDA, APPROVING THE CODIFICATION THE GOALS, OBJECTIVES AND POLICIES OF THE FUTURE LAND USE ELEMENT AND CONSERVATION ELEMENT OF THE DESOTO COUNTY COMPREHENSIVE PLAN: RECOGNIZING THAT THIS CODIFICATION DOES NOT AMEND, REPLACE OR MODIFY THOSE ORDINANCES PREVIOSLY ADOPTED BY THE COUNTY CONCERNING THESE ELEMENTS; APPROVING THIS CODIFICATION SOLELY FOR THE PURPOSE OF POSTING ON THE COUNTY'S WEBPAGE TO ASSIST THE PUBLIC AND STAFF IN UNDERSTANDING AND APPLYING THESE **ELEMENTS:** AND PROVIDING WHEN THIS RESOLUTION SHALL BECOME EFFECTIVE.

WHEREAS, the DeSoto County Board of County Commissioners ("the Board") finds that it is in the best interest of the residents of DeSoto County and serves a proper public purpose to provide codifications of the Future Land Use Element and Conservation Element of the County's Comprehensive Plan; and

WHEREAS, the Board further finds that the codification of the Goals, Objectives an Policies of these Elements should be posted on the County's webpage to assist the public and staff in understanding how the various amendments to each Element fit together into a cohesive whole that can be applied as one document; and

WHEREAS, this Resolution simply approves the codification of these Elements for posting on the County's webpage; and

WHEREAS, by adopting this Resolution the Board does not amend, replace or modify any ordinances previously adopted amending or concerning either Element; and

WHEREAS, the Board authorizes staff to maintain these Elements as current codifications by incorporating any subsequent amendments to either Element into the codifications posted on the County's webpage; and

WHEREAS, the codification of these Elements was presented to the Board on November 17, 2020 for review and discussion; and

WHEREAS, the Board further considered and approved this Resolution at its public meeting held on December 15, 2020.

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DESOTO COUNTY, FLORIDA, THAT:

Section 1. The Whereas clauses above are adopted by the Board.

Section 2. The codification of the Goals, Objectives and Policies of the Future Land Use Element and Conservation Element of the DeSoto County Comprehensive Plan prepared by staff and attached hereto are approved and shall be posted by staff on the County's webpage at such time as the County's Development Director feels it is appropriate.

Section 3. This codification does not amend, replace or modify any previously adopted ordinances amending or concerning either Element.

Section 4. In order to maintain a current codification of each Element, ordinances adopted after the effective date of this Resolution that amend or refer to the Future Land Use Element and Conservation Element of the DeSoto County Comprehensive Plan shall be incorporated into this codification and posted on the County's webpage.

Section 5. This Resolution shall become effective on January 1, 2021.
