GENERAL DESCRIPTION:

This is highly skilled work in the operation of landfill equipment and the operation of the landfill for use by the general public. Work in this position requires a high degree of skill in working to engineer grades. Employees in this class are required to transport liquids from the landfill to a designated site. Employees also operate equipment and assist in the recycling department.

ESSENTIAL JOB FUNCTIONS:

- 1. Operate equipment used at landfill for proper disposal of waste, such as compactor, loader, dozer, and scraper.
- 2. Operate semi-tanker to transport liquids from landfill.
- 3. Performs daily safety inspections of equipment prior to and after use; perform routine service and maintenance.
- 4. Perform necessary tasks to maintain an orderly environment around the working face of the hill, scrap-metal pile, waste tires, household hazardous waste facility, and the entire landfill property.
- 5. Load materials for landfill and recycling departments, as needed.
- 6. Transport materials for recycling department as needed.
- 7. Operate equipment located in recycling department as needed.

(These essential job functions are not to be construed as a complete statement of all duties performed. Employees will be required to perform other job related marginal duties as required.).

REQUIRED KNOWLEDGE, SKILLS AND ABILITIES:

- Knowledge of the operation, maintenance, limitations, and safety precautions of landfill equipment.
- Ability to assist in making general repairs of landfill equipment.
- Ability to understand and carry out oral and written instructions.
- Ability to obtain necessary information and complete accurate reports and daily time sheets.
- Ability to operate equipment over rough terrain and to perform manual labor occasionally under adverse weather conditions.
- Skill in the operation of landfill equipment.
- Knowledge of traffic laws and regulations governing the operation of vehicles on highways.
- Ability to read and follow engineer's plans and drawings.
- Ability to work nights, weekends, and holidays.

EDUCATION AND EXPERIENCE:

High school graduation or possession of an acceptable equivalency diploma and considerable experience in the operation and routine maintenance of equipment used at the landfill.

Possession of a valid Florida Commercial Driver's License, Class A with tanker endorsement (or able to obtain CDL Class A within 6 months of hire). Ability to obtain a Sanitary Landfill Operator's Certificate.

- Acceptable eyesight (with or without correction)
- Heavy lifting and carrying (45 pounds and over)
- Walking, standing, kneeling, bending, stooping, pushing, pulling
- Operate heavy equipment
- Ability to communicate orally

ENVIRONMENTAL CONDITIONS:

- Works outside in various weather conditions with: noise, dust, dirt, mud, fumes, vibrations, and uneven conditions
- In and with moving equipment
- Traffic and hazardous conditions
